

SAGITTARIUS Project – "Launching (g)local level heritage entrepreneurship: strategies and tools to unite forces, safeguard the place, mobilize cultural values, deliver the experience". It was launched in late September 2011, during a conference held in Rhodes – Greece. Its implementation period lasts three years (from 2011 to 2014), and is funded by the South East Europe Transnational Cooperation Programme.

The leader of the SAGITTARIUS Project is the Agean University of Athens, Greece, and it is implemented through 20 institutions in eight countries (Greece, Italy, Romania, Bulgaria, Slovenia, Hungary, Croatia and Republic of Moldova).

Romania has two institutions involved in this project: the Institute of National Economy from the Romanian Academy, together with a partner form a non-EU Member State – the District Council of Soroca, Rep. Moldova (10% partner) and the National Institute for Research and Development of Tourism, with a strategic partner, initially the Ministry of Regional Development and Tourism, in present the Romanian Authority National in Tourism.
